

RESOLUTION No. 2022.3

Resolution Authorizing Teleconference Meeting Options During Proclaimed State of Emergencies

WHEREAS, the Sloughhouse Resources Conservation District ("District") is committed to preserving public access and participation in meetings of the Board of Directors; and

WHEREAS, all regular meetings of the District are open an public, as required by the Ralph M. Brown Act (Cal. Gov. Code 54950-54963), so that any member of the public may attend, participate, and watch the Board conduct its business; and

WHEREAS, the Brown Act, (Cal. Gov. Code section 54953(e)) makes provisions for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Cal. Gov. Code section 54953(b)(3), subject to the existence of certain conditions; and

WHEREAS, a required condition is that a state of emergency is declared by the Governor pursuant to Cal. Gov. Code section, proclaiming the existence of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Cal. Gov. Code section 8558; and

WHEREAS, a proclamation is made when there is an actual incident, threat of disaster,

or

extreme peril to the safety of persons and property within the jurisdictions that are within the District's boundaries, caused by natural, technological, or human-caused disasters; and

WHEREAS, it is further required that state or local officials have imposed or recommended measures to promote social distancing, or, the legislative body meeting in person would present imminent risks to the health and safety of attendees; and

WHEREAS, on March 4, 2020, Governor Newsom proclaimed a State of Emergency to exist in California as a result of the threat of the Covid-19 pandemic and subsequent variants; and

WHEREAS, the Sacramento County Public Health Officer issued the Sacramento County Covid-19 Public Health Order that, in addition to other measures, encourages all individuals adhere with Covid-19 safety measures including social distancing. This Order went into effect on July 30, 2021 and will stay in effect until it is rescinded or amended by the Sacramento County Health Officer. This Order aligns with previous health orders, but supersedes those of 2020 and 2021; and

WHEREAS, the Board of Directors does hereby find that COVID-19 exposure has caused, and will continue to cause, conditions of peril to the safety of persons within the District

that are likely to be beyond the control of services, personnel, equipment, and facilities of the District, and desires to proclaim a local emergency and ratify the proclamation of state of emergency by the Governor of the State of California; and

WHEREAS, as a consequence of the local emergency, the Board of Directors does hereby find that the legislative bodies of PVGSA shall conduct their meetings without compliance with paragraph (3) of subdivision (b) of Government Code section 54953, as authorized by subdivision (e) of section 54953, and that such legislative bodies shall comply with the requirements to provide the public with access to the meetings as prescribed in paragraph (2) of subdivision (e) of section 54953; and

WHEREAS, the conditions described above exist in the District and the District Board of Directors has considered the circumstances of the State of Emergency as well as local orders and recommendations; and

WHEREAS, the District makes all agendas and materials available online, and provides free access to meetings via telephone or Zoom, and all persons requiring additional assistance to access meetings may contact the District Manager, Austin Miller, to request reasonable accommodations; and

WHEREAS, the decision to meet telephonically must be renewed at least every 30 days.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Sloughhouse Resource Conservation District as follows:

1. The Board hereby proclaims that a local emergency now exists throughout the District and ratifies the Governor of the State of California's Proclamation of State of Emergency, effective as of its issuance date of March 4, 2020.

2. The Sloughhouse Resource Conservation District Board of Directors may meet via teleconference, as authorized by Assembly Bill 361 (Rivas, 2021), between the time of this resolution's adoption and 30 days after that date. This Resolution shall take effect immediately upon its adoption and shall be effective until the earlier of (i) March 9, 2022, or such time as the Board of Directors adopts a subsequent resolution in accordance with Government Code section 54953(e)(3) to extend the time during which the Board may continue to teleconference without compliance with paragraph (3) of subdivision (b) of section 54953.

3. All meetings held via teleconference will comply with meeting requirements outlined in Assembly Bill 361. The District Manager and the Board are hereby authorized and directed to take all actions necessary to carry out the intent and purpose of this Resolution including, conducting open and public meetings in accordance with Cal. Gov. Code section 54953(3) and other applicable provisions of the Brown Act.

Multibenefit Program Goals

Overall goal: Support regional efforts to sustain land-based economies and the communities that rely on them while achieving groundwater sustainability

Subgoals:

- Create or restore wildlife habitat and wildlife connectivity, including seasonal wetland habitat to replenish aquifers
- Improve groundwater supply, including through groundwater recharge and improved baseflows in rivers and streams
- Provide benefits to disadvantaged communities and socially disadvantaged farmers and ranchers
- Foster partnerships and collaboration among diverse entities at the regional scale to effectively meet this program's goals
- Develop scalable, transferable land models to reduce groundwater reliance
- Support farmer, rancher, and farm worker leadership in multibenefit land repurposing strategies and project implementation
- Provide **flexible and efficient support to grantees** so that they can lead expeditious and adaptive programs to meet their needs.

Multibenefit Program Activities


Overall: Awardees will develop a Multibenefit Agricultural Land Repurposing Plan that **identifies** and prioritizes projects to address groundwater sustainability within their region.

Details:

- Plans must be consistent with GSPs for the region
- Plans prioritize projects that provide **meaningful benefits to disadvantaged communities** and socially disadvantaged farmers and ranchers.
- Block grant recipients should propose the most effective means to implement projects to meet their goals. This may include subcontracting with conservation partner organizations, paying farmers and ranchers to lead implementation, working with academic institutions, or other options as appropriate.

Activity classes:

- 1. Plan development
- 2. Project development and permitting
- 3. Project implementation
- 4. Outreach/education/training
- 5. Project monitoring and eval

Background

As the Board discussed in January and February, Government Code Section 9084 (The Division of Resource Conservation, Funds and Expenditures) requires that all Resource Conservation Districts receiving funds from the Department of Conservation must prepare an annual and long-range work plans pursuant to Government Code Section 9413 (Resource Conservation Districts, General Powers of District). Additionally, thoughtful annual and long-range plans will provide additional clarity of the Board's interests and priorities to guide staff work.

Director Washburn, District Manager Austin Miller, and community member Kathy Beasley have reviewed the state requirements, reviewed other RCDs' plans, and drafted the attached outline for a SRCD 5-year Plan. Once adopted, this Plan would then inform the development of annual work plans.

Background Info:

- California's Resource Conservation District law (Public Resource Code Division 9) outlines a strategic planning process for districts that includes a 5-year plan, an annual plan, and an annual report.
- 5-year plans define focus areas, establish priorities for action, and provide a structure to hold districts accountable for progress over time.
- Goals for creating a SRCD 5-Year Plan
 - Create a document that combines both achievable and aspirational focus areas and priorities for action
 - o Incorporate active involvement in the implementation of SGMA
 - Recognize SRCD's history of promoting resource conservation in the district
 - Embrace opportunities to broaden and enhance the range of district activities
 - Strive toward a customer-service orientation, providing resources and support for a broader range of stakeholders within the district
- Estimated total length: 15 pages

Outline of 5-Year Plan:

1. Introduction:

a. Brief description, map and history of district; brief summary of past accomplishments; note intensive involvement over past 5 years in SGMA process; end with purpose of 5-year plan (provide a strategy for continuing existing services while embracing both achievable and aspirational opportunities to grow the district's capability to serve a broad range of stakeholders within the district).

2. Overview:

- a. Provide district's Mission, Vision and Goals as adopted previously during the GSP Readiness Plan process (late 2020);
 - i. **Mission:** Our mission is to serve the diverse stakeholders within the Sloughhouse Resource Conservation District to become better stewards of our natural resources through education, outreach, and implementing conservation projects to advance the long-term sustainability of working landscapes, rural life, and our unique environment.
 - ii. **Vision:** Sloughhouse Resource Conservation District supports management of natural resources through collaboration with stakeholders and partners in the district to successfully balance the wide range of programs that protect groundwater for long-term sustainability, soil for agricultural productivity and environmental values, surface water for multiple uses including agriculture, fish, and wildlife, and natural areas for their habitat value.

iii. Goals:

- 1. Have a diverse Board of Directors that represents the community Sloughhouse RCD serves to work together and build better partnerships with community members.
- 2. Collaborate with local, regional, and statewide agencies and develop partnerships on sustainability projects across all focus areas.
- 3. Educate stakeholders and the public about sustainable agricultural and natural resources management.
- 4. Achieve long-term natural resource sustainability goals to prepare for future changes and needs.

3. Identify Priority Focus Areas for SRCD:

- a. **Water Sustainability** (sustainability of groundwater and surface water for all users and stakeholders)
- b. Watershed Health (stewardship of wetlands, wildlife habitat, ecosystems, etc.)
- c. Soil Health and Conservation (support revitalization of damaged soils)
- d. Hazard Planning and Support (flooding, grassland fires, erosion)
- e. **Protection of Rural Lifestyle** (support sustainability of agriculture, ag res, equestrian, recreational land uses, etc. through advocacy and education about laws and regulations.)
- f. Community Engagement (outreach, education, resources, feedback)
- g. **District Operations** (capacity building, board development, RCD Vision and Standards)

4. Identify Potential Barriers and Opportunities:

a. Barriers:

- i. Limited capacity of district's human resources and budget

 - Both surface water and groundwater sustainability are important to Sloughhouse RCD. Groundwater sustainability reflect the ability to

maintain groundwater conditions that support all beneficial uses of groundwater within the Cosumnes and South American Subbasin, in line with our efforts as a Groundwater Sustainability Agency. Surface water sustainability refers to maintaining flows in the Cosumnes River and other waterways that supports farming and environmental uses. Furthermore, the two are interconnected. Surface water can recharge the aquifer and groundwater can contribute to baseflow in waterways. Sloughhouse RCD's attention to water sustainability will be central to all other areas of focus.

 - Sloughhouse RCD's existence is tied to the man-made Dust Bowl of the 1930s, and the need to develop and implement conservation practices to reduce soil loss and promote healthy soil resources. Soil health projects could include addressing erosion issues, increasing water holding capacity and infiltration rates, sequestering atmospheric carbon in the soil, and more.

 - From fires to floods, areas within Sloughhouse RCD have been greatly impacted from a number of natural disasters and continue to be at risk. In addition to worst case scenarios where human life is threatened, productive land can become unproductive, watershed health decline, and countless other negative impacts result from these disasters. Sloughhouse RCD is keenly positioned to work with partners (like Rancho Murieta Fire Safe Council, RD 800, Sacramento Area Flood Control Agency, and others) to minimize risk and support recovery from multiple types of disasters.

Background

As of March 1, 2022, we have generated (via the County of Sacramento's Department of Finance) \$91,998.80 from the Sloughhouse RCD Groundwater Sustainability Fee.

We have received only 3 appeals (totaling \$4,258.44) that Staff approved and processed.

We are anticipating generating an additional ~\$55,000 from the Sloughhouse RCD Groundwater Sustainability Fee in the coming months.

At this time, the Cosumnes Groundwater Authority has indicated that they will propose a Fiscal Year 2022-2023 budget that is similar to Fiscal Year 2021-2022 Budget. This would mean that the Groundwater Sustainably Fee that the Sloughhouse RCD Board of Directors levied in Fiscal Year 2021-2022 would generate adequate funding for our cost share in the coming year.
